Health and Safety Docs

All Foster Carers should have updated Health and Safety documents and these documents need to be sent over to the office or to your SSW. These documents are: - Valid Medical and DBS - Home Insurance - Gas Certificate - Electrical Certificate - Car Insurance and MOT (if applicable) Anyone aged 18 or over who stays in the family home

Anyone aged 18 or over who stays in the family home (including birth children and staying put) need to have a valid DBS check completed by the agency.
